## SHOWS CALENDAR 2019 (vn2)

The following shows holding Donkey Classes have affiliated to the Society for 2018 as at 24 January 2019.

Shows underlined indicate qualifiers for **DBS In Hand Champion Donkey Award**. Donkeys qualify by winning four championships at these shows under four different judges. There is no time limit, although the fourth qualification must be before 31 August for the award to be made in that year, or it will be carried over to the following year. Two of the four shows must have at least 12 donkeys forward in the breed classes to be valid. If you consider your donkey has qualified, please contact the Chairman of the Shows & Judges Committee, Elma Cunningham ([yieldshields@aol.com](mailto:yieldshields@aol.com)).

**In-Hand Champions** at all affiliated shows prior to 31 July will **qualify** for the relevant championships at the **DBS Annual Supreme Championship Show** to be held on 17/18 August 2019. Champions qualifying after this date will be eligible for the relevant championship at the 2020 show.

**Showing points** can be accrued each year from placings at affiliated shows in breed and driving classes by member-owned donkeys, and by junior members in juniors classes. Competitors should record their achievements (show, date, classes, placings) up to 31 August each year and submit them by 14 September to Jade Weaver, Battleoaks Farm, Balcombe Road, Black Corner, Crawley, West Sussex RH10 3NL or email [snowy\\_7002@yahoo.co.uk](mailto:snowy_7002@yahoo.co.uk) (there is an underline between 'snowy' and '7002').

Points can only be accrued from the first ten shows entered in a season.

**In Hand points** are earned in breed classes only: 4 points for 1<sup>st</sup>, 3 for 2<sup>nd</sup>, 2 for 3<sup>rd</sup> at Champion Donkey status shows (indicated below by underlining), and 3 points for 1<sup>st</sup>, 2 for 2<sup>nd</sup> and 1 for 3<sup>rd</sup> at other affiliated shows. No additional points for Champion or Reserve Champion, or for classes at the DBS Annual Championship Show.

**Driving points** are earned per turnout from one of the following classes per affiliated show: Private, Exercise and Open; 3 points for 1<sup>st</sup>, 2 for 2<sup>nd</sup>, 1 for 3<sup>rd</sup>. If the same donkey is driven both singly and in a multiple turnout by the same Whip, this counts as two separate turnouts.

**Juniors** earn points in all classes except breed classes in the first ten shows entered per season as follows: 6 = 1<sup>st</sup>, 5 = 2<sup>nd</sup>, 4 = 3<sup>rd</sup> etc. Only three classes per show will count.
